CROCKETT COUNTY APPRAISAL DISTRICT APPRAISAL BOARD May 31, 2023

The Crockett County Appraisal Board met in open session May 31, 2023 in the Crockett County Appraisal District Board Room 905 Avenue D, Ozona, Texas. Members present were Travis Davidson, G.L. Bunger, and Jarod Shaffer. Chief Appraiser, Janet Thompson along with Tax Assessor, Michelle Medley were also in attendance. Members Wesley Bean and Quay Oglesby were unable to attend.

The meeting was called to order at 12:00 p.m. by Chairman Travis Davidson.

Chairman Travis Davidson noted the Notice of this Meeting of the Appraisal District Board of Directors was posted on May 22nd, 2023 File No. 2068.

G. L. Bunger made a motion to approve the January 25, 2023 minutes as read. The motion was seconded by Jared Shafer. Motion carried 3-0.

The bills paid since January 25th, 2023, were reviewed. G. L. Bunger made a motion, seconded by Jared Shafer, to approve all bills. Motion carried 3-0.

No members of the public commented during the open forum/public comment part of the meeting. No action was taken.

Shane Marsh and Bryan Mathis of Pritchard & Abbott presented the MIUP Contract for the years 2024-2025-2026. Mr. Marsh explained that there is an increase of 6% due to the workload imposed by an increase in division orders. The board voiced their concern over the 6% increase each year making it an 18% increase over the 3-year term. One option discussed was to do a one-year contract and revisit the issue annually, but Mr. Marsh explained that is difficult to do due to timing of budget cycles. All agreed. After a lengthy discussion, G.L. Bunger asked if P&A would consider 6% for year 2024 then 3% for years 2025 & 2026. Mr. Marsh agreed and will draw up new contracts. The renewal was tabled until new contracts are presented. Travis made the motion, seconded by G.L. Bunger. Motion carried 3-0.

Chief Appraiser Janet Thompson gave her quarterly report on the appraisal district and on the 2023 budget to date. The expenditures are in line for the first five months of 2023 with the exception of the Supplies line. We are close to budget due to the expenses incurred during the move to the new building.

Interest Earned on the Appraisal District Checking Account was reported. Interest rates have increased so we are now earning more interest on our checking account funds.

Ms. Thompson also reported the Rendition Compliance Penalty (RCP) amounts we have received to date.

Ms. Thompson presented the Interlocal Agreement between the Appraisal District and the County in regards to rent and utilities at the new location, 905 Ave D. Travis Davidson made the motion to accept the agreement, seconded by Jared Shafer. Motion carried 3-0. Chairman, Travis Davidson and Chief Appraiser, Janet Thompson signed the agreement.

Chief Appraiser Janet Thompson presented the 2024 proposed budget. After review and a short discussion, the proposed budget was accepted by the Board of Directors. Travis Davidson made a motion, seconded by G. L. Bunger. Motion carried 3-0.

Travis Davidson made a motion, seconded by G. L. Bunger, to set the date of August 16th, 2023 for the public hearing for the adoption of the 2024 Budget. Motion carried 3-0.

After review, Travis Davidson made a motion, seconded by Jared Shafer to reappoint all members listed to the 2023 Agricultural Advisory Board. Motion carried 3-0.

Ms. Thompson presented the Guidelines to Qualify for 1-d-1 Open Space and Wildlife Management that must be approved by the board. After a short discussion about minimum acreage requirements, G.L. Bunger made the motion, seconded by Travis Davidson to approve the recommended guidelines. Motion carried 3-0. The Board would like to revisit these after the Ag Advisory Board meets in 2023.

Chief Appraiser, Janet Thompson presented her Disclosure Form and Agreement to Comply with TDLR Rule 94.72 along with registered licensee, Cynthia Hokit.

Non-agenda Items to be added to the agenda for the next meeting: Public Hearing for the adoption of the 2024 Budget. MIUP Contract Update with Pritchard & Abbott.

There being no further business brought before the Board, Jared Shafer made a motion, seconded by Travis Davidson, to adjourn. Mofion carried 3-0. The meeting was adjourned at 12:55 p.m.
